This Newsletter will provide the reader with some insight into the governance arrangements of the National Board. As a registered charity in the Republic of Ireland, we are required to comply with charity regulations from the Charities Regulator including risk assessment and risk management and lobbying legislation. Below you will learn of the controls that are in place to meet these legislative requirements. The National Board also produces an annual report on activities and undertakes an external financial audit. Every year at the AGM of the company Coimirce, Directors, (on a rotational basis) are put forward for re-election for a three year term of office, now with a maximum renewal of two terms per Director. This year's AGM took place by video link in June 2020. The Newsletter will also provide information on activities within the National Office during the Covid 19 health pandemic. We have taken the opportunity to update contact information, review and destroy records in line with our data destruction procedures and update other internal administrative arrangements to ensure we comply with good governance.

Advice and<br/>SupportSister Colette StevensonSafeguarding continues, in spite of staff working reduced hours and remotely. The<br/>Newsletter will provide interesting statistical information on requests for advice,

allegations notified to the National Board, training delivered, planned and research currently in process by the National Office.

We are all getting used to the new reality of working online and holding small meetings using safe distancing. With these changes come additional risks for children that must be considered. We understand the cautiousness with which Church authorities are engaging children in ministry, and while the National Office will not determine whether ministry with children should or should not take place, we can provide support around assessing and managing risks online. Anecdotally we hear of the disappointment from children and their parents and carers about not having the opportunity to meet for sacramental preparation, delayed First Communions and Confirmations. These important milestones in faith development will need to be revisited using a different – blended approach (on-line and in person) which ensures the health and well-being of children.

#### Governance Requirements-Imelda Ashe, Company Secretary

As a company limited by guarantee, and as a registered charity based in the Republic of Ireland, there are Government obligations that much be fulfilled by the National Board. These include external annual financial audit; compliance with the Charities Regulations and cooperation with the Charities Regulator; completion of lobbying returns to demonstrate if the National Board has engaged with Government at any level and compliance with data protection legislation. The National Board reviews each of these expectations on a regular basis, and those which require particular scrutiny are the Charities Compliance Code and Risk Register. In light of Covid 19 and the restrictions on everyone's ability to conduct "business" the National Board's review of risk has changed in some areas. The National Board will continue to monitor whether it has the resources and capacity to undertake its remit.

# A word from Ann Cunningham

Since lockdown commenced on the 13 March 2020 I have had the opportunity to quality check data on the National Board's Contact database.

This task entailed contacting 1547 individuals asking for their permission to remain on the database and to confirm if the information we have for them is still accurate. This exercise proved to be essential as many people had changed their contact details or their job titles. In some instances Church authorities were able to inform me of their plans to step down and who would be stepping into their shoes and when this would take place, giving me the opportunity to send an introductory email to the new Church authority informing them of our work and that we are here to answer any child safeguarding concerns they may have.

We hope to repeat this task every two years. Thank you to all who have responded to my email.

## **Reviews of Child Safeguarding Practice**

The National Board is considering how to undertake Reviews of Child Safeguarding practice using electronic communication where possible, and ensuring safe distancing for on-site visits.

### **Training and Support**

#### **Training Delivered**

Since the last Newsletter published in August 2020 the following training has been delivered:

- Safeguarding Committee Training for two separate religious Church bodies.
- Safeguarding formation input to pastoral theology students in St Patrick's College Maynooth.
- Ministering with Children Online This has been delivered to a further four Church bodies since August.
- Head to Heart Induction for new seminarians

#### **Upcoming Training**

- Online Ministry with Children- This course is specifically designed to assist Church authorities and relevant Church personnel to minister with children online. - Train-the-Trainers Course A number of Church authorities have requested dates for a new Train-the-Trainers course. At present we are looking at the possibility of facilitating this in early December. However, this is entirely dependent on Government advice to ensure that it is safe, both for participants and facilitators. We are continuing to explore how we deliver some of our planned training online, however if there is training you require on any aspect of safeguarding children please contact <u>niall.moore@safeguarding.ie</u>.

### **Training Manuals Pickup**

As noted above, as all of the trainers have now been trained, the PowerPoint slides from the updated training manual have been uploaded onto the trainers' section of the National Board website. If any trainers are having any trouble logging on or have forgotten their log in details please contact <u>niall.moore@safeguarding.ie</u>. There are three different versions of the slides to accommodate those trainers who want to use different software and who have different types of hardware. These are:

- PowerPoint slides with animation
- PowerPoint slides without animation
- Apple Keynote slides

All of the slides have embedded audio clips to make it easier for trainers to use the PowerPoint effectively.

New versions of the certificates have also been provided on the website - one version that can be printed and completed by hand; and another version that can be completed on the computer and then sent on to participants.

In terms of the hard copy training manual, these are in Maynooth (subject to Government restrictions being lifted for the country and ready for collection. We would encourage all trainers to contact <u>imeldaashe@safeguarding.ie</u> to arrange a time that is mutually convenient to pick up the hard copy version of the manual. If other personnel from your Church body are in Maynooth on other business, it is fine for them to collect the manual on behalf of the trainer.

#### **Annual Self Audits**

Indicator 7.1 of the *Child Safeguarding Policy and Standards for the Catholic Church in Ireland 2016* outlines the requirement that Church authorities ensure that an annual self-audit is completed. While this audit is for the Church authority to ensure the implementation of effective safeguarding practice, there is also a requirement to notify the National Board that the audit has been completed. Given the impact that Covid 19 has had on ministry, parish and religious life, added to the absence of children attending for a significant part of this year we understand that conducting a child safeguarding self-audit may not be a priority for many of you this year. We have decided therefore that there will be no requirement to inform the National Board that you have conducted a self-audit for the 2020 period.

### **Data Protection and Data Destruction**

#### **Cookies and Data Protection**

Following new regulations from the European Union the National Board has revised its notification on its use of cookies on the Safeguarding.ie website. It is important that each Church body should consider their use of cookies and the consent that is required from users of their websites. The Data Protection Officer of each Church body can assist with this.

#### **Data Destruction**

- Over the past number of months the National Board has been going through a process of data destruction. This overall process is broken down into a number of streams of work outlined below:
  - Allegations data from 2008-2019- This has now been returned to the relevant Church bodies and all electronic copies have been destroyed from the National Board's records.
  - Allegation data from 2019-2020- Following publication of the 2019 Annual Report data received during this
    period will be returned to the relevant Church authorities. Letters have been sent to all Church authorities
    in Ireland where we hold allegation data. We would urge all Church leaders who have received a letter from
    us to arrange a date to pick up the data as soon as possible. If you do not wish to collect your data and
    would like the National Board to destroy it please confirm this in writing. If you have not received a letter,
    and would like to find out if we hold allegations data belonging to your Church body please contact
    acunningham@safeguarding.ie or imeldaashe@safeguarding.ie.
  - Allegations which the National Board received from one Church body where the respondent belonged to another Church body- This data will now be returned to the Church authority who originally shared the data with the National Board. In the coming weeks all relevant Church authorities will receive a letter encouraging collection of this data. If you have not received a letter and would like to find out if there is data which you need to collect please contact acunningham@safeguarding.ie or imeldaashe@safeguarding.ie.

#### Guidance, Advice and Practice (GAP) Papers

The National Board has now written two further in a series of eight GAP papers. The final GAP papers of 2020 will deal with Information Sharing and a further GAP paper will review Children's Rights in Child Safeguarding. The Information Sharing Paper will be presented to the Board for approval in October and will be released on the National Boards website thereafter.

The Children's Rights Paper will be released later in the year.

## National Conference-Theology of Safeguarding

The National Board's biennial conference due to take place in October 2020 has been postponed until 13<sup>th</sup> and 14<sup>th</sup> October 2021. In line with the National Board's desire to create a focus within the Catholic Church in Ireland on the consideration of, reflection on and development of theology in relation to the safeguarding of children, the theme of the Conference and for our work during 2021 will be the Theology of Safeguarding. We intend hosting a series of videos on our website over 2021 featuring experts in safeguarding and theologians responding to questions which will then lead us into a discussion at the Conference in 2021.

## Notification of Allegations and Advice Offered by the National Board

The National Board is required, as one of its functions, to monitor the notification of allegations to statutory authorities. While identifying information is not shared with the National Board, we do track if allegations, suspicions and concerns are notified to An Garda Síochána, PSNI, Tusla and Social Services in Northern Ireland. We report on this statistical data annually in our Annual Report.

The National Board is regularly consulted on case management matters, procedural and practice initiatives. Given the current health pandemic the National Board decided to share a comparative statement on the amount of advice offered and the allegations received between June to September 2020 with the same period in 2019.


**Allegations Comparison**

## Safeguarding Statements – Requirement of *Children First* for Church bodies with ministry with children in the Republic of Ireland

Child Safeguarding Statements are a statutory requirement of *Children First*. The development of a statement demonstrates how an organisation which engages with children assesses and manages risk during activities. Church bodies that have ministry with children are required to comply with this aspect of *Children First*. To assist in the development of a child safeguarding statement, the National Board developed a template, with links to all the required procedures on 29<sup>th</sup> January 2018.

Following advice from Tusla this statement was updated on 27<sup>th</sup> of September 2019 and again on 21<sup>st</sup> of November 2019. Following feedback from Church personnel regarding localised risk, it was updated again on 6<sup>th</sup> of December 2019 and as with all of our guidance all of these updates were highlighted in the latest update box on the website, on the child safeguarding app and in our Newsletter under the 'Guidance update section'.

It is important to review the update template to ensure compliance with *Children First* requirements on Safeguarding Statements.

The National Board has regularly communicated information about changes needed to safeguarding statements in Newsletters and at Ecclesiastical Provincial area meetings.

The National Board understands that Tusla's Compliance Unit is checking safeguarding statements and failure to comply with the expectations around regularly assessing and managing risk and reflecting this in an updated statement may result in a Church body being placed on a register of non-compliance. Over the past few weeks, the National Board has reviewed a random sample of safeguarding statements on Church bodies' websites to assess whether they are in line with updated guidance, and we have noted that is not the case. The current National Board template has been confirmed as compliant by the Compliance Unit in Tusla, and we would urge all relevant Church bodies to review their statement against the National Board's template available here
