### Welcome

Welcome to the National Board for Safeguarding Children in the Catholic Church in Ireland's (NBSCCCI) September edition of our Newsletter. We hope you all had an opportunity for rest and relaxation over the summer period.

After a very busy spring, the NBSCCCI staff have been taking time during the summer to undertake work on data protection, retention and purging records, information sharing and to plan ahead for 2017 in terms of training and support. Details of all these issues are located in the body of the Newsletter. In October 2016 we will be hosting our second National Conference. Please ensure you are registered to attend as numbers will be capped and we do not want you to be disappointed. Staff met all the speakers over the last two months and we are excited with the programme which we have planned and will be placed on our website in the coming davs. (www.safeguarding.ie). Please note that NBSCCCI's website has been revamped and we hope that information is more easily accessible. Please let us know your views.

The NBSCCCI has met with the Chair of the Northern Ireland Historical Institutional Abuse Inquiry to share our Policy and Standards. In addition the Royal Commission in Australia has consulted with the NBSCCCI and has sought copies of the Safeguarding Children Policy and Standards (2016) as well as the accompanying guidance.

### Safeguarding Children: Policy and Standards for the Catholic Church in Ireland 2016

Copies of Safeguarding Children 2016 have been distributed across the Catholic Church. If you require further copies (€10 per copy) please contact <u>imeldaashe@safeguarding.ie</u> as supplies are now running low.

All Church Authorities have been asked to sign a revised Memorandum of Understanding and Data Processing Deed (s) to sign up to their commitment to follow Safeguarding Children 2016. Almost all Church Authorities have now completed this process and the NBSCCI will place a list of constituent members on the website in the near future. If you have not yet signed and wish to do so, please do this and return it to <u>ann.doyle@safeguarding.ie</u> by 19 September 2016.

### Child Safeguarding Review Methodology

A consultation document was circulated on 14<sup>th</sup> June 2016 and again on 17<sup>th</sup> August, seeking initial views on reforms to the review process for child safeguarding practice. The consultation date has been extended until 5<sup>th</sup> September, to allow for those who are on holiday. Your views are being sought on:

- Should future reviews by the NBSCCCI be conducted in the same manner as the first round, i.e. using consultants who conduct an assessment of compliance against the relevant Standards?
- If a Church authority requests a review, does he/she accepts that there may well be adverse findings which have to be highlighted in the subsequent written Review Report?
- If there is an openness to change the way in which reviews are conducted, should the views of complainants be sought and represented?
- If there is an openness to change the way in which reviews are conducted, should the views of respondents be invited and represented?
- If there is an openness to change the way in which reviews are conducted, should the views of children and young people who participate in the Church, and of their parents / guardians, be invited and represented?
- Are there justifiable and defensible circumstances in which a decision might legitimately be made not to publish the full report of a review?

Once responses are received the working group will reconvene to draft a methodology for future reviews which will be presented to the Sponsoring Bodies for approval.

# **Information Sharing**

The NBSCCCI has consulted the Data Protection Commissioner in the Republic of Ireland and as a result, is in the process of developing a Privacy Impact Assessment (will be required under an EU directive coming out in 2017). Once completed, this will be shared with the Data Commissioner (ROI), the Information Commissioner (N.I) and the Church Authorities' legal advisors.

#### Collaborative Work with Towards Healing and Towards Peace

NBSCCCI has been undertaking joint work with Towards Healing and Towards Peace to develop thinking about what constitutes a compassionate and effective pastoral response to the needs of adult victims of clerical child sexual abuse. This initiative has been taken by the three agencies to mark the Extraordinary Jubilee of Mercy. As Pope Francis reminded us in April 2015 when he was announcing the Jubilee,

### Practice Issues: Vetting (Republic of Ireland)

Staff from the NBSCCCI met with Superintendent Sarah Myler and Sergeant Marissa Costello to clarify a number of matters relating to Garda vetting. The following is a summary of points:

- The National Vetting Bureau (Children and Vulnerable Persons) Act 2012 was passed by the Oireachtas in 2012, and was amended by the Criminal Justice (Spent Convictions and Certain disclosures) Act 2016. The legislation has now been commenced by ministerial order and came into effect on 26<sup>th</sup> April 2016
- The Act makes it a criminal offence, for a Church authority to **commence** the employment of an employee or engagement of a volunteer (including priests and religious)without first obtaining a vetting disclosure from the Bureau in respect of that person, where that employee or volunteer is undertaking relevant work or activities with children or vulnerable person. Church Authorities are required to ensure that applications for statutory vetting have been made in respect of all such persons **before 31 December 2017**
- Section 21 of the Act, which commenced on 29 April 2016, concerns retrospective vetting of employees, volunteers and others who have never previously been vetted and who are already (i.e. prior to 29 April 2016) employed, contracted, permitted or placed by the Church to undertake relevant work or activities with children or vulnerable persons. Church Authorities are required to ensure that applications for statutory vetting have been made in respect of all such persons before 31 December 2017
- A move to E-Vetting is recommended (please contact the Garda Vetting Bureau to set up e-vetting). E-vetting checks take 5 working days
- Visiting priests and clergy can apply for vetting in advance
- Vetting is required in both jurisdictions where a member of the Church ministers across Northern Ireland and the Republic of Ireland
- 16-18 year olds require parental consent prior to being vetted

#### Tusla Central Reporting for Allegations against Clerics and Religious

Tusla (Child and Family Agency) have started a short consultation on the benefits of developing a single point of contact for notifications of allegations against priests and religious. If developed, this will form Phase 1 of a single point of contact for all "retrospective" allegations in Ireland, irrespective of the organisation of the respondent.

Notifications will be processed through a Tusla office in Blanchardstown and from there will be forwarded to local social work teams for assessment. The Blanchardstown team will be able to track notifications, similar to the central Garda National Protective Services Bureau in Harcourt Square. There are still a number of matters to be resolved including agreeing a single notification form (which meets the needs of an Garda Siochana and the NBSCCCI) before the project is established. Tusla will write to Church Authorities confirming a start date and contact details for this central reporting office.

Tusla have now stated that they require all allegations, including those against deceased clerics and religious, are reported to them. Their rationale for receiving allegations against deceased members is to allow them to offer counseling to the complainant and to clarify that there is not a case of mistaken identity.
